The above specified fee is meant for all categories of students under convenor quota. The students/parents need not pay over and above the fee specified in the concerned G.Os. Any discrepancy may be brought to the notice of the A.P. Higher Education Regulatory & Monitoring Commission, Tadepalli, Guntur District (grievanceaphermc@gmail.com). Collection of higher fee than the prescribed amounts to collection of Capitation fee and is punishable under the provisions of the Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Act No.5 of 1983) and the APHERMC Act 20 of 2019.

Soon after the display of the above information, you are directed to submit a photocopy of the notice thus displayed, to the office of the APHERMC within a week duration, but not later than 31st January, 2022, other wise, appropriate action will be initiated as per the Act, Rules and Regulations of the APHERMC.
