





Course of One year from the academic session 2002-03 with an annual intake of 120 students.

- On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - The institution has acquired the land for setting up the teacher education institution.
 - The institution has constructed the building for conducting the course on the abovementioned land.

The institution has made arrangements for conducting the course in rented / temporary promises.


- The institution has created an Endowment Fund of Rs.5.00 Lakhs and a Reserve
- Fund of Rs. 651183 iv) The institution has selected the Principal / Head and 12 teachers for the said course.
- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to GAYATHRI COLLEGE OF EDUCATION, VIZIANAGARAM DT, ANDHRA PRADESH for B.Ed. Course of One year from the academic session 2002-2003 with an annual intake of 100 students subject to fulfillment of the following:
 - a) The institution will ensure that 12 faculty members duly approved by the affiliating body are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Committee within one month of commencement of the course.
 - b) The institution shall, within one month of the receipt of order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.






Annexure 10: Mutation






